### **TRIP TO GREECE**

#### **1. SWEEPSTAKES/CONTEST**

The Sponsors are not responsible for lost, late, incomplete, or otherwise misdirected entries that are processed late or incorrectly or are lost due to computer or electronic malfunction or other error. Only one entry per person is permitted. Multiple entries will result in disqualification. NO PURCHASE IS NECESSARY FOR ANY PART OF THE CONTEST.
